## IMMUNIZATION POLICY

1. All nursing students are required to complete the recommended immunizations as prescribed prior to clinical posting or coming in contact with patients/clients.
2. Students are required to submit the proof of immunizations before health check up / starting clinical posting.
3. Students who do not complete recommended immunizations in time will not be sent for clinical posting.
4. Students who are allergic to any vaccines / immunizations are contraindicated need to submit the medical certificate as a proof for not being immunized.
5. Additional immunizations may be required in case of any disease outbreaks.
6. Students who are applying for international clinical experiences / willing to work abroad shall meet the immunization requirements for the destination country.
7. The applicable costs of immunization are the responsibility of individual student.
8. Students must inform their supervisors about the immunization status in relevant clinical situations.
9. Students shall inform their faculty if they are suffering from any diseases at the time of immunization.
10. All students shall support the prevention and control of transmission of infectious diseases by supporting immunization programs.

## IMMUNIZATION POLICY FOR EMPLOYEES IN AMALA INSTITUTE OF MEDICAL SCIENCES, THRISSUR

1. Immunization is suggested for groups at risk of acquiring infection who have not been vaccinated previously.
2. All health care workers who may have occupational exposure to blood or other potentially infectious materials are required to be immunized and proof of immunization should be submitted as a condition of enrollment in to training and employment.
3. All healthcare workers should have completed the full course of hepatitis B vaccinations
4. Booster dose after the primary dose should be received on the scheduled time.
5. The health care workers who are previously immunized for hepatitis B should produce the titer adequate certificate
6. Additional immunizations may be required in case of any disease outbreaks.
7. The applicable cost of immunization is the responsibility of individual staff.
8. Staff who are allergic to any vaccines or immunizations are contraindicated need to submit the medical certificate as a proof for not being immunized.
9. Susceptible personnel who do not have contraindications to chicken pox immunization should be given two doses of varicella vaccine at least 30 days apart.
10. The newly appointed employees should be immunized after employee orientation and within ten days of initial work assignment.
11. All staff shall support the prevention and control of transmission of infectious diseases by supporting immunization programs.
