#### ORDER

As per paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2017-18 from colleges for courses affiliated to this University. The Principal, Amala College Of Nursing, Thrissur-MN004 has submitted application for the continuation of provisional affiliation for the year 2017-18 vide paper read (2) above. The 23rd meeting of the Governing Council vide decision No 23.19 has "decided to conduct inspections for granting Continuation of provisional affiliation once in every two years in all colleges except those colleges where first batch of UG/PG courses has passed out". Since the first batch has been passed out and no deficiency was pointed out in the last year Inspection, inspection for 2017-18 is not conducted

On verification of the applications it is found eligible to grant Continuation of Provisional Affiliation to Amala College Of Nursing, Thrissur-MN004 for the academic year 2017-18 as they have remitted necessary fee, of KUHS and have obtained permission from the Central/State council for the academic year 2017-18 vide paper read fourth and fifth above. As per the minutes of the 40th G.C held on 24-07-2017 vide decision No.40-23 (A), it was decided to grant Continuation of Provisional Affiliation for 2017-18 to colleges mentioned in table A without conducting inspection as the first batch has passed out and no deficiency was pointed out during previous inspection.
