2. The applications were processed by the University and Inspections were conducted in the Colleges. The reports submitted by the Inspection Commission vide paper read (3) above were verified by the Scrutiny Committee. The deficiencies pointed out by the Committee vide paper read (4) above were intimated to the Colleges and the Colleges have furnished the Compliance reports vide paper read (5) in connection with rectification of deficiencies.

3. The whole matter was placed before the 46th Governing Council held on 08/06/2018. The Governing Council vide paper read (6) above had decided to grant Continuation of Provisional Affiliation for the year 2018-2019 to the Nursing Colleges whose In Patient strength is above 75% on the day of inspection for conducting all the existing courses subject to the submission of approval from Kerala Nurses and Midwives Council and rectification of other deficiencies noted by the Scrutiny Committee.
4. After verification of the inspection report, the Scrutiny Committee vide paper read (7) above recommended to grant Continuation of Provisional Affiliation to the under mentioned Colleges for the Year 2018-2019.
5. Vide paper read (8) above the Colleges have submitted renewal permission from Kerala Nurses and Midwives Council, Thiruvananthapuram for the Academic Year 2018-19. The Indian Nursing Council, New Delhi vide paper read (9) has published the list of State Nursing Council recognised Institutions offering Nursing Programmes inspected under section 13 and 14 of INC Act. The colleges are included in the list published by INC. As per Chapter XXI of First Statutes read as (10) above the Colleges have constituted College Council.
6. After considering the whole matter in detail, sanction, has, therefore been accorded by the Pro Vice-Chancellor by implementing the decision No. 46.38 (i) of the Governing Council to grant Continuation of Provisional Affiliation to the below mentioned colleges for conducting the courses with an annual intake of students mentioned against each during the Academic Year 2018-19 subject to ratification of Vice Chancellor and Sanction is also accorded to grant Continuation of Provisional Affiliation to **DM WIMS College of Nursing, Wayanad , Crescent College of Nursing, Alathur and Red Crescent College of Nursing, Kozhikode** for the Year 2018-19 subject to ratification by the Vice Chancellor and the Governing Council as these colleges and courses come under the purview of the above said decision of the Governing Council.

2) In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998. the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

3) Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.

4) The Colleges should remit annual administration fee fixed for UG/PG courses for the academic year 2018-19

5) Admission to the next academic year shall be made only after obtaining prior permission from the University.
