6. The colleges shall strictly adhere to the general conditions detailed below,

i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, falling which the affiliation granted will be cancelled.

II. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
